1. 73% **Strongly Agree** and 27% **Agree** with suitability of the course and need based.
2. 64% **Strongly Agree** and 36% **Agree** that the has increased knowledge and perspective in subject area..
3. 55% **Strongly Agree** and 45% **Agree** with sufficient number of optional papers.
4. 59% **Strongly Agree** and 41% **Agree** that syllabus has good balance between theory and applications.
5. 77% **Strongly Agree** and 23% **Agree** for freedom to adopt new techniques.
